12a. The submittal review process is to be completed. It will be necessary for the equipment and material suppliers to prepare the submittals and forward the submittals to the electrical contractor or general contractor. Equipment submittals forwarded to the electrical contractor will in turn be forwarded to the contractor. The contractor will forward the submittals to the Construction Manager. The Construction Manager will forward the submittals to the Engineer of Record. Electrical Submittals will be forwarded to the Engineer of Record's Electrical Sub-consultant. The initial submittal review will be completed and sent in the reverse order described until the equipment or material suppliers obtain the reviewed submittal.

Submittals can be "Approved with No Exception", "Approved as Noted", or requested to be "Revised and Resubmitted" or "Rejected". If the submittals

are revised and resubmitted or rejected then the entire submittal process described above must be repeated. It is anticipated that several submittals will go through two or three iterations until approved. The manufacturing of equipment and materials are not commenced until approved submittals are received. It is estimated the submittal process for this project will require two (2) weeks or 14 Calendar Days.

12b. The manufacture, shipping and delivery of the control panel, chemical pumps, chlorine analyzers, electrical equipment, chemical tanks and other system components is expected to require up to seven (7) weeks or 49 Calendar Days for long lead items.

12c. Construction of the piping, concrete slabs, sodium hypochlorite shade system, electrical system and equipment is expected to require 68 calendar days. Work on these items is expected to occur concurrently with the lead time items.

12d. Start-up of equipment and instrumentation. Operator Training. Start-up of equipment and instrumentation and operator training is expected to require 7 calendar days.
